- It is the responsibility of the Principal and Programme Officer, the grant released by the University Regular and Special Camping programme should be displayed on the Notice Board of the college for information of the NSS volunteers along with Schematic Budget provided by the University.
- Each unit must have one or two adopted village where the NSS volunteers should initiate literacy, awareness and health programmes for the benefit of the community, as per the action plan provided by the University.
- As and when any transfer / retirement of the Programme Officers occurred, it is the responsibility of the Principal that the Programme Officer should submit all the dues such as reports, accounts and other records to the Principal, failing which it is unfair to relieve the Programme Officer(s).
- 8) As and when the Programme Officer relieved, immediately the matter should be informed to the JNTUK NSS Programme Coordinator.
